RIGHT TO ACCESS TO PERSONAL DATA (ex art. 15 Reg. EU n. 679/2016)

I ask for the access to personal data concerning me, expressly requesting:

1. confirmation of the existence of personal data concerning me, even if not yet registered;
2. that they, if any, have been communicated to me in an intelligible form,

- e) confirmation of the existence of an automated decision-making process, including the profiling referred to in Article 22, paragraphs 1 and 4 of the GDPR;
- f) if the data are transferred to a third country or to an international organization, the existence of adequate guarantees pursuant to Article 46 of the GDPR relating to the transfer.
